## Pacific Business Group on Health Advocates Health Reform through National Priorities Partnership

Goals Targets Patient-Centered, Affordable Healthcare by Reducing Disease Burden, Disparities and Waste

Washington, D.C. (Nov. 17, 2008) – PBGH has partnered with a diverse coalition of 28 major national organizations to unveil a broad agenda to fundamentally reform health care. In representing those who receive, pay for, deliver and evaluate healthcare, the National Priorities Partnership identified six target areas to advance world-class, patient-centered, affordable healthcare.

The Partnership's improvement agenda targets health reform in ways that will eliminate harm, eradicate disparities, reduce disease burden, and remove waste. The "National Priorities" are:

- Patient and Family Engagement, to provide patient-centered, effective care;
- Population Health, to bring greater focus on wellness and prevention;
- Safety, to improve reliability and eliminate errors wherever and whenever possible;
- Care Coordination, to provide patient-centered, high-value care;
- Palliative and End-of-Life Care, to guarantee appropriate and compassionate care for patients with advanced illnesses; and
- Overuse, to remove waste and achieve effective, affordable care.

"PBGH seeks to leverage quality information, value purchasing and performance rewards to engage consumers and providers," said David Lansky, PhD, PBGH President & CEO. "To catalyze breakthroughs in quality and system re-engineering, these elements must be aligned with a national framework that supports value."

"We're in a vital window of opportunity to advance real healthcare change," said Peter Lee, PBGH's Executive Director for National Health Policy. "PBGH and its members are excited to engage with key stakeholders to promote performance transparency and payment reform." Moving into 2009, PBGH and the Partnership will undertake specific, measurable actions to deliver better, more affordable care.

"The key is focusing on the right places in our vast and fragmented "system" where we can achieve the greatest dividends for patients and their families. If leveraged strategically, increments of improvement can accrue into transformational change and a much higher-performing healthcare system," said Janet Corrigan, president and CEO of the nonprofit National Quality Forum, which convened the National Priorities Partnership.
