Leapfrog Announces 2019 Top Hospital Award for California Hospitals Sixteen Receive Coveted National Distinction

San Francisco, CA, December 17, 2019 – The Leapfrog Group and Pacific Business Group on Health announced today sixteen hospitals have been named to its 2019 national list of Top Hospitals. The elite award is one of the most competitive honors American hospitals can receive in safety and quality. The winners will be officially recognized at Leapfrog's Annual Awards Dinner and Ceremony on December 17, 2019 in Washington, D.C.

Pacific Business Group on Health is a Leapfrog Regional Leader, working with providers, purchasers, payors and patients in to drive safe, high-quality health care. "Purchasers applaud the hospitals that stand up for accountability and transparency when they participate in the Leapfrog Patient Safety Survey," said Emma Hoo, PBGH Director. With a one in 25 chance of leaving a hospital with a new infection, consumers can check how effectively their local hospitals keep their patients from errors, injuries, accidents, and infections on the Hospital Safety Grade website (https://www.hospitalsafetygrade.org/).

The Leapfrog Group is a national nonprofit watchdog organization that rates hospitals on patient safety, as well as the effectiveness of procedures and other care they provide. This year, Leapfrog recognized 120 Top Hospitals across the country. Of those, 10 were Top Children's Hospitals, 37 Top General Hospitals, 18 Top Rural Hospitals and 55 Top Teaching Hospitals. "The standards achieved by Top Hospitals reflect the high expectations set by Leapfrog and its expert panels, which starts with a commitment to transparency," said Leah Binder, president and CEO of The Leapfrog Group. "We are honored to spotlight the hospitals that have truly gone above and beyond in their pursuit of excellence that protects patients and saves lives."

The Top Hospital award is given to teaching, general, rural and children's hospitals that publicly report their performance through the Leapfrog Hospital Survey and meet the high standards defined in the Top Hospitals Methodology. This includes infection rates, maternity care and a hospital's ability to prevent medication errors, among other standards.
