If you are still working on making corrections, the last day to resubmit a measurement file will be September 8th, 2023 (Cycle Test 1 Closing Day). After that day, you will have the opportunity to make corrections to your data as we move into the new measurement period of Cycle Test 2.

We will host optional Office Hours on Thursday, October 5 from 11:00AM-12:00PM (please accept the Outlook invitiation to confirm your attendance). Improvement Advising Implementation Plan and IMAT/Needs Discussion Results

As we transition into September, we'd like to take a moment to recognize the significant activity since we launched in July, including attending three CalHIVE BHI Commons learning sessions, submitting two data submissions and preparing for our upcoming in-person convening. Thank you to all teams for completing Section 1 Pre-Work of the Implementation Plan. Implementation Plan Sections 1 and 2, which will be released during the 9/12 meeting and sent via email after the meeting, will be due Friday, September 29.

Our team has been synthesizing the cohort-wide trends from individual IMAT/Needs Discussion Improvement Advising meetings. We will share a highlevel summary of shared strengths and opportunities at the September 12 meeting.
