As a reminder, Section 3 (Staffing) of the Implementation Plan and the Org Chart PowerPoint are due Tuesday, October 31 to your Improvement Advisor. Additionally, we are now releasing <u>Section</u> <u>4 of the Implementation Plan</u> (PHQ-9 Screening), which will be due Thursday, November 30. Your Improvement Advisor will review the questions and highlight resources in meetings this month.

Resource Snapshot: DHCS Equity and Practice Transformation (EPT) Program

For organizations who provide Medi-Cal, the Department of Health Care Services has launched applications for the EPT Provider Directed Payment Program. The application for this program is due by October 23, 2023 at 11:59 pm P.T.

Application instructions are found here. Statewide, \$650 million (\$325 million General Fund) over 5 years will support delivery system transformation, specifically targeting primary care practices that provide primary care pediatrics, family medicine, internal medicine, primary care OB/GYN services, or behavioral health services that are integrated in a primary care setting to Medi-Cal members.
