In January 2024, CalHIVE BHI team members joined the San Francisco Health Network team for the relaunch of their PCBH program. The meeting was attended by over 100 medical, behavioral health and care team members to reflect on the program and identify improvements to advance the program's goals. Data

As we approach the first data collection cycle of the year on April 12, we wanted to share news to streamline the program's data reporting requirements. From April 2024 (Baseline Cycle) onwards, the following measures will be required for reporting:

- Enrollment (ENR)
- Depression Screening & Follow-up (DSF)
- Depression Remission or Response (DRR)
- Diabetes Care: HbA1c Poor Control >9% (HPC)

The measures related to unhealthy alcohol use screening and follow-up (ASF) and emergency department visits (EDV) have been retired from the program.

Additionally, beginning with Cycle 1 (due July 12) we'll be asking each of you to report pilot site data based on Section 6 (Measurement Plan) of your Implementation Plan.

Further details will be shared during February's improvement advising calls and the data webinar on Thursday, March 7. Jose Ordonez will be available to address any questions you may have. Thank you for your ongoing efforts to support the collection and reporting of data.

Resource Snapshot: Free Digital Behavioral Health Platforms for Children and Families.

This January, CalHOPE launched two digital behavioral health solutions to support families and young people access free, safe and confidential mental health support. BrightLife Kids (for ages 0-12) and Soluna (for young adults ages 13-25) are web- and app-based platforms providing all California families free oneon-one support with a live wellness coach, a library with age appropriate multimedia resources, wellness exercises and moderated peer communities. These platforms are part of California's Master Plan for Kids' Mental Health and the Children and Youth Behavioral Health Initiative (CYBHI).
